

#### Installation

- 1. uPVC Conduit, pipe sizes as per Table 1
- 3M™CP 25WB+ Sealant depth minimum 26 mm flush with plasterboard, in annular gap up to 10 mm 2.
- 3. If walls have an FRR less than that of the seal, then FRR of the seal reduced to match FRR of wall, up to -/180/90
- Walls with less than 26mm of plasterboard may be patched. Follow GIB guidelines (75mm min from seal edge)
